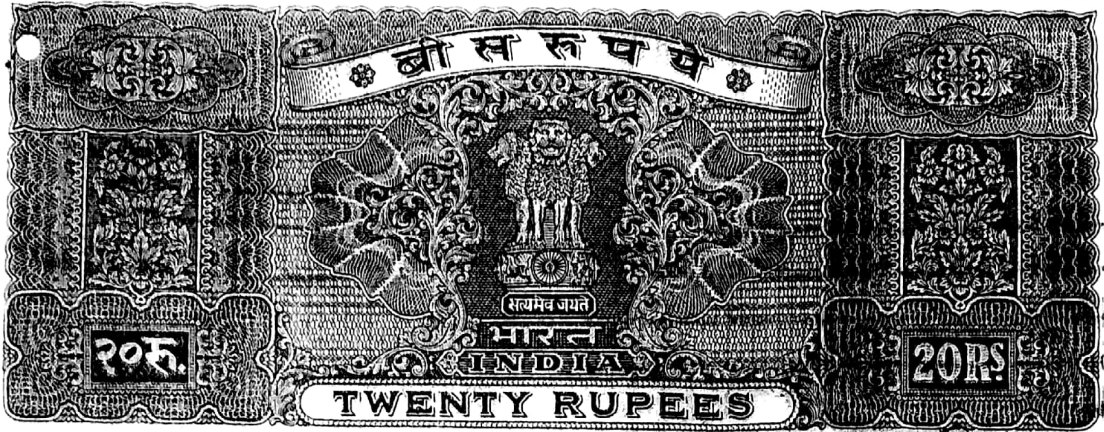

This Deed of Declaration of Trust is made by me, V.BASHINGAM, Do Varadappan, No.4 candappa mudali street, Pondicherry. (hereinafter called the "AUTHOR" which expression shall mean and include his heirs legal representatives, successors and assigns wherever the context so admits or requires)

**Definitions.**

1. The "Trust" means Alpha Charitable Trust
2. The "Trust Fund" means
  - a) The sum of Rs.10,000/- (Rupees Ten thousand only) to be deposited in any Bank by the Author in the name of the Trust as nucleus to the Trust Fund.
  - b) All moneys investments and donations paid or transferred to and accepted by the Trustee either from the Settler or any one else, and investments and properties from time to time, representing such money, investments and donations or any part thereof including capital gains arising from sale or transfer of any of its assets as computed under the Income-Tax Act, 1961.
  - c) Income or balance of the income of every year which is not distributed amongst the beneficiaries within six months from the expiry of the accounting year of the Trust.
  - d) "Trustees" means the Members of the first board of Trustees under this Deed and shall unless excluded by repugnant to the subject and context be deemed to include the trustee or Trustees for the time being of these presents and / survivor or survivors of any of them and their successor or successors in Office).

Objects of the Trust

The objects of Trust are as follows:


1. To establish, maintain, run, manage, take over, acquire, improve, extend, up-grade or donate and assist in the establishment, maintenance, running development, improvement and extension of Nursery Schools, Elementary, Middle or Secondary Schools, High Schools, Higher secondary schools, College of Arts, Fine Arts, Music, Science, Medical, Engineering and Polytechnics and generally all kinds of educational institutions whether general, industrial, technical, vocational, professional, residential or of other description whatsoever for the welfare and uplift of the general public.

2. To acquire by purchase, gift or otherwise, lands, house-sites and building. To erect, build and construct or to aid and assist in the erection, construction and building of houses, buildings for educational institutions and colleges, libraries, staff quarters, hostels, and/or other type of building or construction whatsoever and to maintain or run them and if necessary to alter, demolish or reconstruct them or any portion or portions thereof as may from time to time necessary or expedient.

3. To acquire and take over all or any part of the immovable or movable properties of any society, trust or Institution or any one whomsoever for the purposes of the Trust.

4. To enter into any arrangement, contract or partnership with any Government (State or Central) Authority or person whomsoever and to obtain from any Government, quasi-Government Authority or person such rights, concessions and privileges as the Trust may think fit or desirable and to obtain, carryout, exercise and comply with any such arrangement, contract, privileges, right or concession grants.

5. To accept donations, endowments, gifts, devises, bequests (real or personal) grants-in-aid and subscriptions for all or any of the purpose of the Trust on such terms and conditions as the Trust may consider reasonable and fit.

To collect, manage and disburse the funds raised or to be raised for all or any of the objects of the Trust. To give provide and/or render help and assistance to and/or implement any scheme for providing livelihood and upliftment of the poor.

14. To give, provide and/or render food, medicine and other help and/or assistance in any shape or form to the poor deserving and needy persons

15. To give, provide and/or render monetary and/or other help and assistance for the relief of persons and animals affected by natural and other calamities such as flood, fire, famine, cyclone, earth-quake, storm, accident, pestilence, drought, epidemic, unbearable cost of living and the like to give donations, subscriptions or contributions to institutions, establishments, centers or persons doing relief work on such occasions.

16. To start, maintain and assist any relief measures in those parts which are or become subjected to natural calamities such as flood, fire, drought, famine, cyclone, earth-quake, epidemic, storm, accident, pestilence etc.

17. To establish, maintain or grant aid for the establishment or maintenance of wells, tube-wells tanks, water-reservoirs, and trees and constructions of and repairs to paths, roads bridges etc. for the use of public

18. To give, provide, distribute dhooties, blankets, rugs, woolen clothings, quilts of cotton, woolen, silk or other varieties of clothes or other articles of necessity and facilities for the poor.

19. To foster and encourage education and training in handicrafts, fine arts, among women folk in general establish and found institutions imparting such education and to establish,

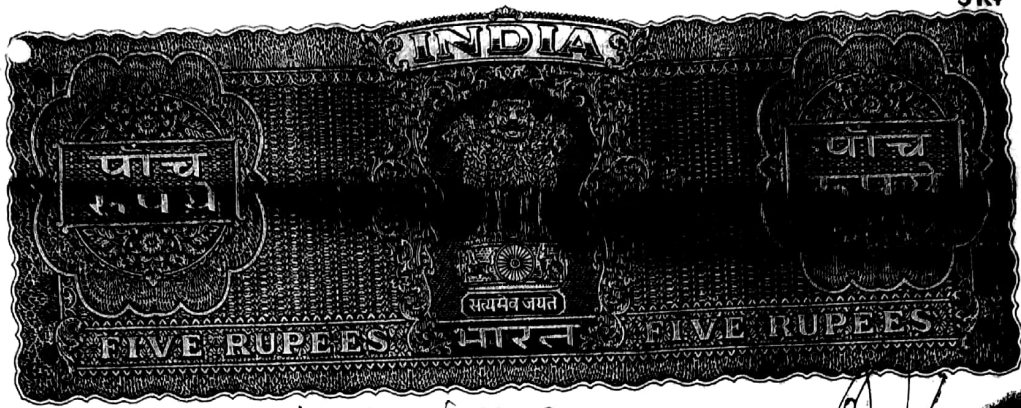

26. To help in the preservation of cattle and useful animals endangered species.

27. To publish and/or publishing books pamphlets, periodicals and newspapers in India or outside for the spread and advancement of education and culture.

28. And generally to do and cause to be done all such lawful things as may be required for all or any of the above objects from time to time.

29. To start, run, maintain, conduct, organize, crèche, orphanage, home for aged and disabled, rehabilitation center, cottage industries, SSI units etc.

PROVIDED that all such objects shall be those treated as Public and Charitable and exempt for the purposes of exemption under the provisions of the Indian Income Tax Act 1961, and/or other Direct Taxes and shall not include application of the funds of the Trust in violation of the provisions of Sec - 13 of the Income Tax Act or any other provisions of the said Act and/or any other Act or Acts as may be applicable to Educational and Charitable Trusts, the income of which is exempt as they now stand and as may be amended from time to time.

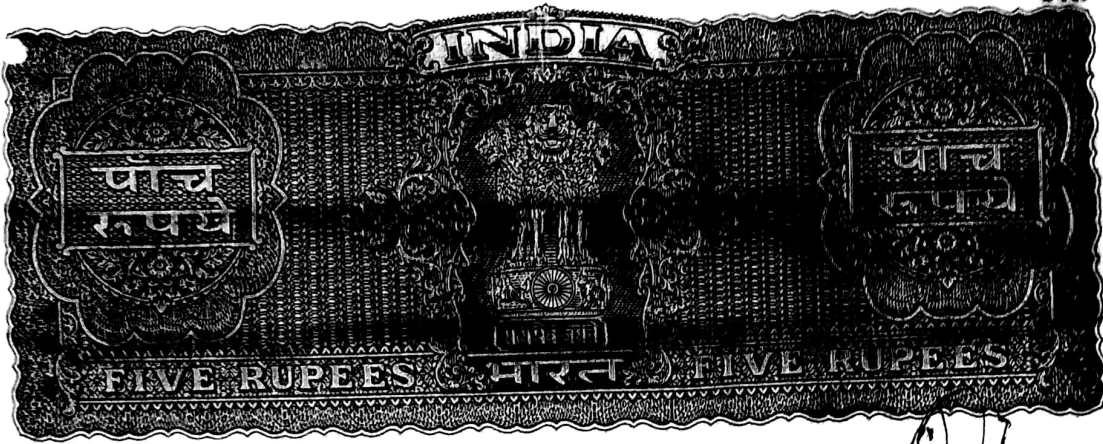
The Trustees appointed by the founder shall be the First Trustees. The first Trustees shall be the Trustees for life unless they shall voluntarily resigns.

If any one or more of the objects specified and defined above of these presents are held not to be objects of a public charitable nature, the trustees shall not carry out such object or objects as if the same are not incorporated in these present but the validity of the trust created by the presents as a trust for public charitable purposes shall not be affected in any manner.

The financial year of the trust shall end on 31st March, every year provided that the Board of Trustees shall be at liberty to change the same from time to time if they so deem it fit and proper. The first financial year of the trust shall close on 31st March 2001.

The trustees shall from time to time after meeting the expenses of and incidental to the management of the trust properties and of the Trust decide the particular object or objects for which the income and corpus of the Trust fund or properties for the time being available shall be applied.

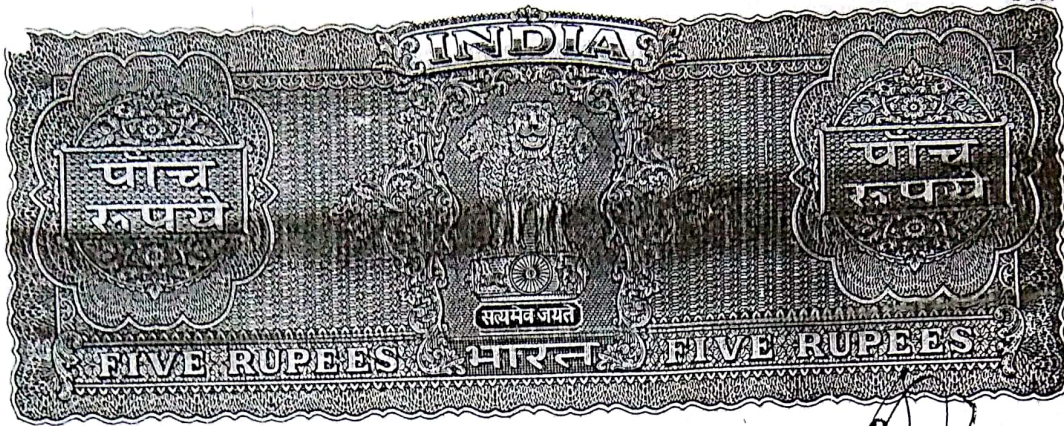
The trustees may accept any donation or contribution in cash or in kind from any person, company corporation, association, institution, or trust (including the Author or the trustees or any of them) state and central government and their departments public undertakings for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not inconsistent with the objects of the trust. The trustees may also take over the management of any other charitable or public institutions on such terms as they think fit and may manage such institutions.

Without affecting the generality of powers and functions of the trustees to manage and administer the trust, the Board of Trustees shall have the following functions:

- i) To borrow if needed by against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision or agreement and to authorize two or more of the trustees to execute such documents deeds, papers, etc., as may be necessary in connection therewith.
- ii) To arrange for and/or authorize the signing or execution of any agreement, contract, instrument, document or any other paper on writing required to be signed or executed on behalf of the trustees by any two of the trustees to be nominated in this behalf by the Board of Trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees.
- iii) To appoint or make provision for the appointment of sub-committee of trustees and/or others to attend to or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the trustees may prescribe.

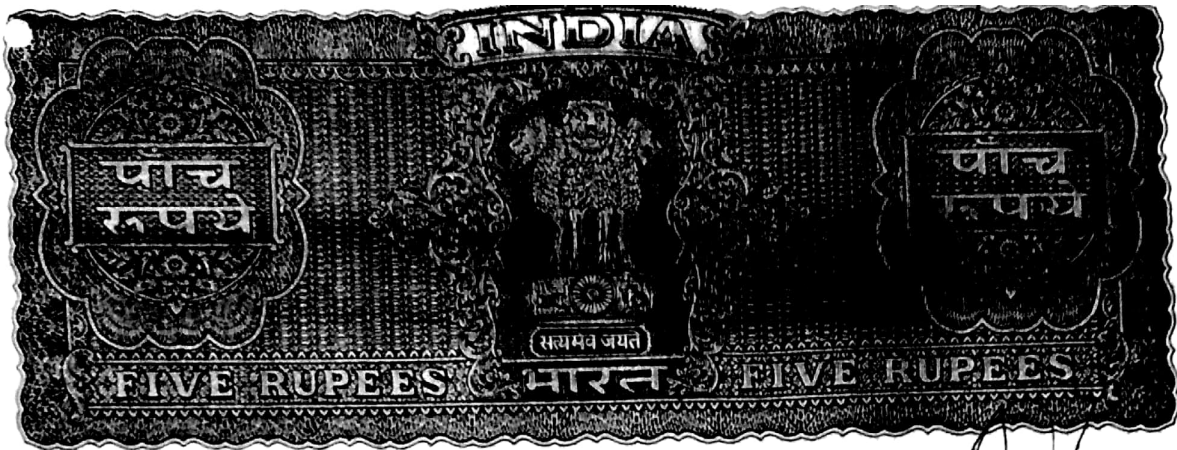
v) To spend any portion of the corpus or the income of the Trust Fund for purchasing any land and or constructing any building or buildings for and in the name of the Trust for the purpose of carrying out promoting and/or executing any or all of the objects of the Trust.

The Trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management's of trust properties or in relating to the carrying out of the objects and purpose of the trust as well as of all the assets, credits and effects of the trust properties

The Trustees may invest the Trust Estate either in the purchase of immovable properties or of mortgage immovable properties or in such manner as allowed by laws as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time provided that such investment shall not be made which are directly or indirectly for the benefit of any person referred in sub-section (3) of section 13 of Income Tax Act 1961 subsequent amendments as may be made from time to time. If the income from the trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the Income -tax Act, 1941 shall be carried over to the next year or years and spent in such sub-sequent year or years for the advancement of any of the object of the trust.

The Trustees shall be at liberty to sell such portion or portions of the movable or immovable properties forming part of the trust Estate either by public action or private contract at such price or prices and in such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned thereby and to execute all conveyance or other assurances and to pass valid and effectual receipts, and discharges for all moneys received by them

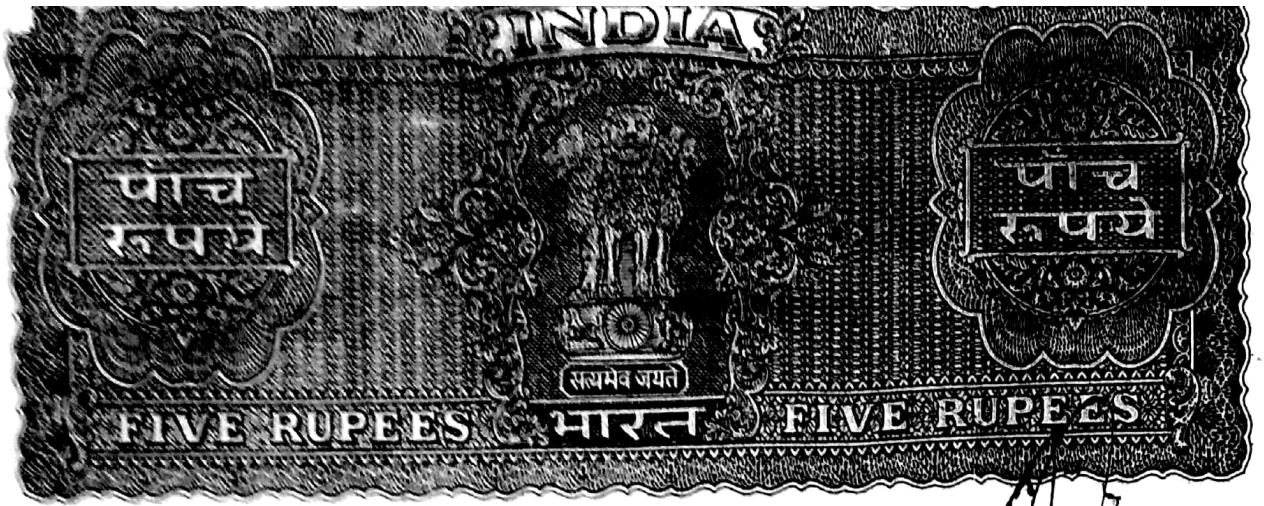
The trustees shall keep on account or accounts with any bank or banks either in the name of the Trust or in joint account with any body, to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorize by appropriate resolution one or more of the trustees jointly appointed by the Board of Trustees in this behalf to operate such account or accounts or to close such accounts.

The Trustees may pay all charges and out goings payable in respect of any immovable property for the time being forming part of the trust fund and may carry out repairs required to be done to the same and keep the same insured against loss or damage by fire and may incur all other costs, charges and expenses incidental to the administration and management of the trust Estate and the properties for the time being belonging to the Trust as they may in their absolute discretion think fit. The Trustees may manage or supervise the management of any lands, hereditaments and premises for the time being comprised in the Trust Estate or any part thereof with power to erect, pull down, re-build, add, to alter and repair houses, and other buildings, and to build drains and make roads and fences and otherwise to improve, develop and to cultivate, or cause to be cultivated all or any of the said lands hereditaments and premises and to insure houses and buildings against loss or damage by fire and/or otherwise or to let lease, make allowably all to deal with the said lands, hereditaments and premises as they may deem fit in their absolute discretion.

The trustees may appoint secretaries, Managers, Lawyers, solicitors, Auditors, Architects, Engineers, Surveyors, Gamesters or other employees for the purpose of management and supervision of the Trust Estate, for collection of rents, effects of rents and profits, for keeping the accounts and records and for other purposes of the trust.

The trustees may establish its office at such place or places and may change such places from time to time as they may think fit.

The trustees may demise the immovable property or properties for the time being and from time to time belonging to the trust either from year to year or for any fixed term or for any term of years or on monthly tenancies at such rent and subject to such covenants and conditions as they may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they think proper.
